<p>Violation #49. Non-food contact surfaces clean Observed reach in cooler gaskets soiled with mold-like substance. Clean and sanitize gaskets. Operator cleaned and sanitized. COS.</p> <p>CODE REFERENCE: 64E-11.003(4). Non-food contact surfaces shall be kept clean and free of an accumulation of dust, dirt, food residue, and other debris.</p>
